His practice spans ad hoc and institutional proceedings under the ICSID, LCIA, ICC, and ICDR Rules, with particular expertise in disputes involving technical, scientific, and complex construction issues, especially in the energy sector. He also brings significant knowledge of US, English, and international investment law.

Brian's professional background includes senior leadership roles as Principal of Baker & McKenzie International and Chair of the Firm's North American Disputes Group. His authority in the field is widely recognised: Chambers Global ranks him in Band 1, Who's Who Legal lists him as a Thought Leader, and Euromoney identifies him as one of the world's leading experts in commercial arbitration.

In addition to his arbitral practice, Brian has contributed to the development of arbitration as an adjunct professor at the University of Toronto Faculty of Law, as a member of the Council of the American Arbitration Association, and as Chair of the Canadian Advisory Committee to the ICDR. He is also the author of *Arbitration Law of Canada: Practice and Procedure*, now in its fourth edition, which is frequently cited by Canadian courts including the Supreme Court of Canada.
