Jessica Crow is an independent arbitrator with Arbitra International and an academic at the University of Cambridge. She specialises in energy and natural resources, climate change and the environment, international dispute resolution, and public international law.

Jessica has served as Arbitrator, Tribunal Secretary and Counsel in complex, high-value disputes across numerous industries including energy, construction, infrastructure, insurance (including political risk insurance), telecommunications, fintech, transportation, joint ventures, and commercial matters. With fifteen years of experience in international commercial and investment arbitration, she has been engaged under most major arbitral institutions and across multiple governing laws and seats.

Jessica is widely recognised for her expertise in the law and governance of the energy transition, climate change, and environmental matters. Her work is underpinned by deep knowledge of international climate policy frameworks, emissions trading regimes, and renewable energy regulation. Her practice includes advising corporates, investors, and governments on international and domestic climate policy, ESG frameworks, and political and climate-related dispute risk. She writes and speaks extensively on these topics.

As a Fellow at the World Economic Forum, Jessica engages with global business leaders, policymakers, and international organizations on the climate governance agenda. She contributes to high-level stakeholder consultations on corporate climate ambition, transition risk and achieving net zero.

At the University of Cambridge, Jessica teaches international dispute resolution, climate law, and environmental policy and is a researcher in climate litigation at the Cambridge Centre for Environment, Energy, and Natural Resource Governance (CEENRG). She holds appointments as the Hoffmann Fellow in Global Climate Governance at the Centre for Climate Engagement, Hughes Hall and as a researcher at the Lauterpacht Centre for International Law.

Before becoming a full-time arbitrator and academic, Jessica worked in private practice at leading global firms in London and Paris, acting as counsel for corporates, states, and state-owned entities in international commercial and investment arbitration. Additionally, she has in-house experience with an Engineering Procurement and Construction (EPC) company in the energy sector and served as a Special Legislative Assistant to the government house leader in the Parliament of Ontario, Canada.

She speaks fluent English and French, and is admitted to practice in New York and as a solicitor in England and Wales.

She teaches international law, climate change and environmental law at the University of Cambridge where she is a doctoral researcher.
