Monique Sasson is an experienced international arbitrator with over thirty years of expertise in analysing and resolving complex cross-border disputes. She is dually qualified as an Italian *avvocato*, an English solicitor, and a New York attorney. Her distinguished academic background includes a Ph.D. in International Law from Cambridge University.

Before establishing herself as an independent arbitrator, Monique practiced at major international law firms in London and Rome and served as a litigation lawyer at Morgan Stanley in New York. She is a founding partner of DeliSasson and was previously Of Counsel at Macchi di Cellere Gangemi.

Monique as arbitrator, has sat in numerous proceedings under ICC and other institutional rules. Her sectoral experience spans energy, construction, financial instruments, corporate and commercial disputes, and public international law. She has also served as an expert witness, notably in *CEAC v. Montenegro* (ICSID Case No. ARB/14/8), where she testified on international law before a prominent investment treaty tribunal.

Monique has published extensively and is the author of *Substantive Law in Investment Arbitration* (Kluwer, 2017, 2nd edition). She is listed as an arbitrator with Arbitra and regularly appointed in high-stakes international matters.

The tribunal's lengthy award was confirmed by the Dutch courts. Monique is currently sitting as sole arbitrator in an ICC case (under Israeli law) involving the construction of a solar power plant. She also has experience as counsel in FIDIC contract disputes under English law. Monique is a frequent speaker at international conferences on FIDIC contracts and infrastructure arbitrations.
